***IT IS NECESSARY TO TAKE AN APPOINTMENT**

1. Provide for EACH person in the household ONE of the following proofs of identity:
<ul style="list-style-type: none"> • Valid Medicare card (RAMQ) • Valid driver's licence • Valid Canadian passport • Permanent residency confirmation/card • Immigration documents (Ex : Asylum Seeker/Refugee document, Valid Work Permit or other)
2. Provide ONE of the following proofs of address:
<ul style="list-style-type: none"> • Lease/Rent contract/Landlord receipt • Letter from landlord or from person who signed the lease • Hydro Québec bill • Home telephone bill/Home cable bill (i.e. Bell Canada, Videotron or other)
